DC/22/06096 Bramble Cottage, The Tye, Kersey, Ipswich Suffolk IP7 6HB Householder Application - Erection of first floor rear dormer extension (retention of)

The Council gave unanimous support for this application.

DC/22/05153 Greenfields, Vale Lane, Kersey, Ipswich Suffolk IP7 6EH

Application for works to Tree subject to Tree Preservation Order WS243/T18 - Reduce Crown of 1No. Oak (T1) by 40%

The Council agree to give the following response to Babergh regarding this tree application: The tree in question is a large well-established oak which forms an important part of the village landscape. The Council queried whether the oak, which is some 20 metres to the North of the Greenfields bungalow is actually the cause of the reported subsidence. The building is on a clay site subject to shrinkage and expansion. The cracks could be a result of the type of foundations used during construction. Work to stabilise the property may be a better long-term solution. The Council would oppose any proposal to remove the tree or cut it to the base. After discussion, it was reluctantly agreed to support the application to reduce the crown of the oak. However, the Council seek assurances that the work would be commissioned and monitored by the applicant, Suffolk County Council.

7/23 Any other business – Councillors' opportunity to bring matters to the Council's attention

Concerns were raised about:

The number of potholes in the Parish, the time taken to complete repairs and the quality of the repairs. The Chair will bring this to the attention of Robert Lindsay our County Councillor.

The poultry in the Bell garden which are roaming free. Current Avian Flu regulations mean they should be enclosed.

The slippery slide steps and rubber chips at the playground. This will be referred to the Clerk.
